

MASC Online Services Contest Rules

1. This contest is conducted by the Manitoba Agricultural Services Corporation (MASC). The contest begins on the mailout date of MASC's Seeded Acreage Report and ends on Harvested Production Report deadline of November 30, 2017.
2. NO PURCHASE NECESSARY. Each Seeded Acreage Report, Carryover Grain Production Report and/or Harvested Production Report submitted through MASC's Online Services will be considered as the insured's entry into the draw.
3. Three handheld Grain Moisture Testers with a Digital Bushel Weight Scale, each with an approximate retail value of \$500 (CDN), will be given away. A random draw for this prize will take place on December 11, 2017.
4. Odds of winning depend on the number of Seeded Acreage Reports, Carryover Grain Production Reports and/or Harvested Production Reports submitted through MASC's Online Services.
5. MASC will make reasonable efforts to contact the selected entrant by telephone within one week of the draw date. Before being declared the winner, the selected entrant must: (a) correctly answer, unaided, a time-limited mathematical skill-testing question to be administered at a mutually convenient time over the telephone; (b) be in full agreement and compliance with these contest rules; and (c) agree to the publication by MASC of their name as the contest winner. A selected entrant who cannot be contacted or who does not agree or comply with these contest rules will be disqualified and an alternate winner will be chosen.
6. This contest is open to insureds who have submitted their Seeded Acreage Report, Carryover Grain Production Report and/or Harvested Production Report through MASC's Online Services. MASC directors and employees and their family members residing in the same household are not eligible to enter the contest. The decision of the contest judges is final in respect of any matter relating to the contest. This contest is subject to all federal, provincial and municipal laws and regulations.
7. MASC reserves the right to cancel, terminate, modify or suspend this contest, or extend the deadline for this contest, at any time for any reason. If the contest is terminated or suspended, MASC may select the winner by a random draw from eligible entries received before that time.
8. The prize must be accepted as awarded, is not transferable and cannot be converted to cash. MASC reserves the right to substitute a prize of equivalent value if the particular prize is not available for any reason. MASC will make all reasonable efforts to deliver the prize to the declared winner as soon as possible after the random draw.
9. The winner is responsible for, and releases MASC and its agents and representatives from, all claims, injuries, damages, losses and costs related to or in any way arising out of this contest (including, without limitation, the delivery, acceptance, insurance and use of the prize).
10. Under no circumstances will MASC, or its directors, officers, and employees, be required to award more prizes than what is indicated in these rules or award the prize other than in accordance with these rules.
